A. IDENTIFICATION & LOCATION

1. Name

- 1.1 This building was never officially named by tile Board of Trustees.
- 1. 2 Alternate names noted:

The first section was built under architect's project number 3915. This project included also the original unit of Canfield (Bldg. 098) and the final addition to Mack (Bldg. 100). The name on the drawings is "Women's Dormitory--Unit B." The entire project was also referred to as "Women's Dormitories."

The additions were built under architect's project number 5245. This project included also Bradley (Bldg. 097), Paterson (Bldg. 103) and the Canfield addition (Bldg. 098). The name on the drawings is "Women's Dormitory--12th Avenue Project." At the time of the addition, this building was referred to in the Lantern (7/29/54) as the "Canfield Refectory."


Current Business Office reports list this facility as "Women's Residence Food Service." Earlier it was listed as "Residence Hall Refectory."

The name "Oxley Dining Hall" has also been noted.

3.1 Type of construction:


Reinforced concrete frame with brick exterior.

B. PLANNING & CONSTRUCTION--FIRST SECTION

See Canfield Hall (Bldg. 098), "Part B. Planning & Construction--Original Building" for information relative to the planning and construction of the first section of the Women's Dining Hall.

The kitchen equipment contract for the dining hall portion of the project was awarded by Cabinet to the John Van Range Co. on November 16, 1939 (T) and this action was approved by the Board of Trustees on December 11, 1939.

C. PLANNING & CONSTRUCTION--ADDITIONS

See Bradley Hall (Bldg. 097), "Part B. Planning & Construction" for information relative to planning and construction of the additions to the Women's Dining Hall.

The kitchen equipment contract was let to the John Van Range Co. on April 20, 1953 along with the other contracts for the entire group of "Women's Dormitories" constructed at this time.

Bradley and Paterson opened in January 1955 (L 1/5/55). An open house was held on January 30, 1955 and refreshments were served in the large dining hall serving Bradley and Paterson (L 1/31/55), presumably the second section of the Women's Dining Hall.

D. COST

- 1. Starting in 1939-40, the cost was carried in Business Office reports at \$95,039.22.
- 2. The cost of the addition was apparently included in a total for "Residence Halls for Women" until 1967-68, at which time a figure of \$579,192.88 was reported for "Women's Residence Hall Food Service." Deduction of the \$95,039.22 for the original refectory leaves \$484,153.66 as the cost of the addition and any subsequent changes to June 30, 1968.

The cumulative total remains at \$579,192.88 as of June 30, 1971.
