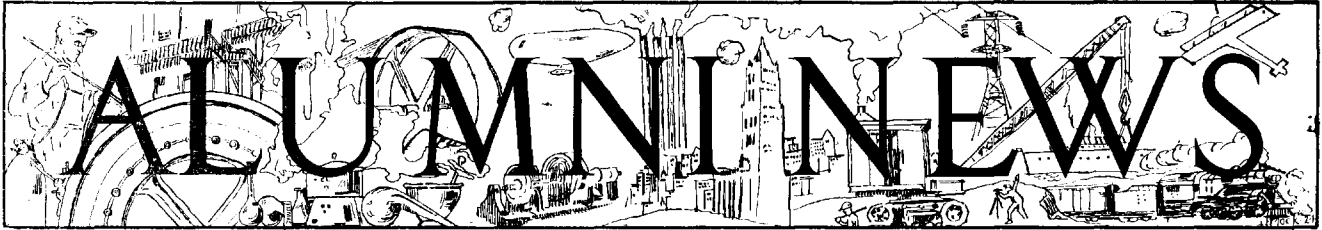

Blake P. Sherman, B. M. E., 1921, is located for the present at Orrville, Ohio, assisting his father in his shoe store.

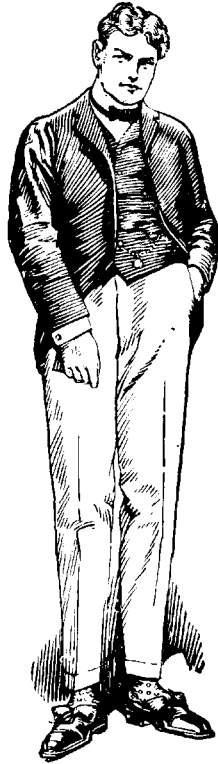
