Manuscripts and illustrations should be prepared in triplicate and submitted to Dr. Tim M. Berra, Editor, *THE OHIO JOURNAL OF SCIENCE*, Department of Zoology, Ohio State University at Mansfield, 1680 University Drive, Mansfield, OH 44906.

Publication in *THE OHIO JOURNAL OF SCIENCE* requires consideration of editorial costs. These will be assessed at \$40 per page for members and \$60 per page for non-members for the first 12 printed pages and \$95 per page (full production costs) for each page in excess of 12. Additional charges will be added to cover the cost of cuts in papers with 3 or more figures and in Brief Notes with 2 or more figures.
