WARREN BARGAD (Ph.D., Brandeis University, 1971) is the Milton D. Ratner Professor of Hebrew Literature at the Spertus College of Judaica. He is the author of *Hayim Hazaz: Novelist of Ideas*, and co-author (with S. F. Chyet) of *Israeli Poetry: A Contemporary Anthology* (forthcoming).

MORDECHAI BEN-ASHER מ'ר (Ph.D., Hebrew University, Jerusalem, 1968) was a Senior Lecturer of Hebrew Language at the University of Haifa until his sudden death on December 24, 1976. The following are among his numerous publications: *The Crystallization of Normative Grammar in Modern Hebrew* (in Hebrew), Tel Aviv, 1969; Hebrew translation of Bergsträsser's *Hebrew Grammar*, Jerusalem, 1972; *Essays on the Syntax of Modern Hebrew* (in Hebrew), Tel Aviv, 1973.

JOSHUA BLAU (Ph.D., Hebrew University, Jerusalem, 1950) is the Max Schloessinger Professor of Arabic Language and Literature at The Hebrew University of Jerusalem. He is also a member of the Hebrew Language Academy and the Israel Academy of Sciences and Humanities. He is the author of numerous publications, among which are the following: *The Responsa of Moses ben Maimon I-III* (in Hebrew), Jerusalem, 1957-61; *A Grammar of Medieval Judeo-Arabic* (in Hebrew), Jerusalem, 1961; *The Emergence and Linguistic Background of Judeo-Arabic*, Oxford, 1965; *Pseudo-Corrections in Some Semitic Languages*, Jerusalem, 1970; *Phonology and Morphology of Biblical Hebrew* (in Hebrew), Tel Aviv, 1972-73; *The Renaissance of Modern Hebrew and Modern Literary Arabic* (in Hebrew), Jerusalem, 1976; *A Grammar of Biblical Hebrew*, Wiesbaden, 1976; *An Adverbial Construction in Hebrew and Arabic*, Jerusalem, 1977.

MARC BREGMAN (M.A., Hebrew Union College, 1971) is a doctoral candidate in Hebrew Literature at The Hebrew University of Jerusalem and is teaching at the Hebrew Union College, Jerusalem.

PINCHAS DORON (Ph.D., New York University, 1975) is a Lecturer in Classical and Oriental Languages at Queens College, CUNY. He is the author of *Nehemiah Kalomiti's War of Truth*, New York, 1978.

BARUCH HALPERN (A.B., Harvard College, 1973) is a doctoral candidate at Harvard University and Lecturer in Humanities, Religion, Judaica and

Education at York University (Canada). His publications have appeared in the *Journal of Biblical Literature*, *Catholic Biblical Quarterly*, and *Vetus Testamentum*.

CHARLES D. ISBELL (Ph.D., Brandeis University, 1973) is an Associate Professor of Old Testament at the Nazarene Theological Seminary in Kansas City, Missouri. His publications have appeared in *The Biblical Archaeologist*, *Biblical Archaeology Review*, *Bulletin of the American Schools of Oriental Research*, *Catholic Biblical Quarterly*, *Journal of Biblical Literature*, *Journal of Near Eastern Studies*, and elsewhere. He is the author of *Corpus of the Aramaic Incantation Bowls*, Missoula, 1975; *Biblical Hebrew* (with H. E. Finley), Kansas City, 1975.

DAVID C. JACOBSON (Ph.D., University of California, Los Angeles, 1977) is an Assistant Professor of Hebrew Studies at The University of Michigan, Ann Arbor.

GILA RAMRAS-RAUCH (Ph.D., Bar-Ilan University, 1976) is a Lecturer in Hebrew Literature and Comparative Literature at Bar-Ilan University. In 1977-78, she served as a scholar-in-residence in the Department of Near Eastern and Judaic Studies at Brandeis University. Her numerous works on Hebrew and world literature have been published both in Israel and in the United States. Her book on Y. H. Brenner and existentialism (in Hebrew) will soon be published in Israel.

NORMAN ROTH (Ph.D., Cornell University, 1978) is an Assistant Professor in the Department of Hebrew and Semitic Studies at the University of Wisconsin, Madison. He received the Messenger-Chalmers Prize from the faculty of Cornell University for a study of the medieval Hebrew poetry of Spain.
